NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further-sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel of lot of land, with all impreventents thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenvilla, on the Western side of Old Hickory Point, near the Town of Mauldin, being shown and designated as Lot No. 10 on a plat of FORRESTER WOODS, Section One, made by R. B. Bruce, Surveyor, dated March 14, 1972, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book 4-N, at page 78, and having, according to said plat, the following mates and bounds, to-wit:

BEGINNING at an iron pin on the Western side of Old Hickory Point at the joint front corners of Lots Nos. 9 and 10 and running thence along the common line of said Lots N. 62-24 W. 150 feet to an iron pin; thence along the line of property now or formerly owned by G. M. Smith S.: 27-36 W.110 feet to an iron pin; thence along the common line of Lots Nos. 10 and 11 S. 62-24 E. 150 feet to an iron pin on Old Hickory Point; thence along the Western side of Old Hickory Point N. 27-36 E. 110 feet to an iron pin, the beginning corner.
