## MORTGAGE

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (heremalter referred to as Mortgagee) in the sum of Thirty-five Thousand ODe Hundred Dollars

(§ 35,100,00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note and payable as therein stated or as modified by mutual agreement, in writing, the final malfirity of which is 25 years after the date hereof unless extended by mutual consent, the terms of said note and any agreement modifying it are townsporated herein by reference, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagor on other or no security.

NOW, KNOW ALL MEN. That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagor at any time for advances made to or for his account by the Mortgagor, and also in consideration of the further sum of Three Dollars \$43.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the realing and delivery of those presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagor, its successors and assigns.

"All that Certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate lying and being in the State of South Carolina, County of Greenville, fronting on Crescent Avenue, being shown as Lot 5, on a plat of Cagle Park made by R. E. Dalton dated August 1924, and recorded in Plat Book F, page 251, and having according to said plat, the following meter and bounds, to-wit:

BEGINNING at an iron pin at the joint corner of Lot 4 and Lot 5 and running thence along Cremeent Avenue 80 feet to an iron pin; thence along the line of Lot 6 S. 30-46 W. 161.5 feet to an iron pin; thence along the line of Lots 9, 10 and 11, N. 59-03 W. 80 feet to an iron pin; thence along the line of Lot 4 N. 20-23 R. 156.4 feet to the point of beginning.

In addition to and together with the monthly payments of principal and interest under, the terms of the note secured hereby the mortgager promises to pay to the mortgages for the term of the guaranty policy the sum of 1/48th of 1% of the original amount of this loan in payment of the mortgage guaranty insurance covering this loan and on his failure to pay it, the mortgages may advance it for the mortgager's amount and collect it as part of the debt secured by the mortgage.

The mortgagors agree that after the expiration of ten years from the date hereof, the mortgages may at its option apply for mortgage insurance for an additional period of five years with the mortgage insurance company insuring this loan, and the mortgagor agrees to pay to the mortgages as premium for such insurance one half of 1% of the principal balance existing.

Together with all and singular the rights, members, hereditaments, and appurirenancia to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which max arise or he had therefrom, and including all healing, plumbing, and lighting flatures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto is any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture; he considered a part of the real estate.
