Beginning at an iron pin on the eastern side of Dunham Bridge Rd., John corners of lot numbers 9 and numbers 8, and running thence south 49-56 E. 491.8 feet to an iron pin; thence S. 15-56 W. 76-9 feet to an iron pin; thence N. 5-1-06 W. 506.5 feet to an iron pin; and thence N. 27-56 E. 84 ft. to an iron pin; the point of beginning.

To have and to hold, with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, unto said Mortgagee, provided always, and this instrument to make, executed, sealed and delivered upon the express condition that if the said Mortgagors shall pay in full to the said Mortgagee the above described Note according to the terms thereof, then this Mortgage shall cease, determine and be void, otherwise it shall remain in full force and virtue.
