conditions), said upte to be repaid with interest as the rate or rates therein specified in installments of One Hundred Eighty

WHEREAS, said more further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulation set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

NOW KNOW ALL MRN, That the Mixigagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgages to the Mortgages a secount, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and trilly paid by the Mortgages at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and peleased, and by these presents does grant, bargain, sell and release unto the Mortgages, its successors and assigns, the following described real estate:

All that certain piece parcel or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate lying and being in the State of South Camblina, County of Greenville, at the southeastern corner of the intersection of Pheagant Trail with Bounder Road, being shown and designated as Lot No. 41 on a plat of FORRESTER WOODS, Section I, made by R. B. Bruce; Surveyor, recorded in the R.M.C. Office for Greenville County, Sr C., in Plat Book 4-N, at page 78, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Pheasant Trail at the joint front corners of Lots Nos. 41 and 42, and running thence along the common line of said lots S. 27-36 W. 136 feet to an iron pin; thence along the northern side of Lot No. 44 N. 62-24 W. 140 feet to an iron pin on Boulder Road; thence along the eastern side of Boulder Road N. 27-36 E. 110 to an iron pin; thence with the curve of the intersection of Boulder Road with Pheasant Trail, the chord of which is N. 72-26 E., 35.5 feet to an iron pin; thence along the southern side of Pheasant Trail N. 62-43 E. 115 feet to an iron pin; the beginning corner.
