"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 244 on plat of the property of Sherwood Forest, recorded in Plat Book GG, Pages 70 and 71, in the RMC Office for Greenville County, S. C., and having according to said plat the following metes and bounds, to wit:
