NOTE AND MORTGAGE
MODIFICATION AND ASSUMPTION AGREEMENT

- (1) That the loan balance at the time of this assumption is \$7,781.23. That the OBLIGORS agree to repay said obligation in monthly installments of \$117.17 each with payments to be applied first to interest and then to remaining principal balance due from month to month with the first monthly payment being due January 22, 1973.
- (2) That all terms and conditions as set out in the note and mortgage shall continue in full force, except as modified expressly in this Agreement.
- (3) That this Agreement shall bind jointly and severally the heirs, successors and assigns of the Mortgagee and OBLIGORS, their heirs, successors and assigns.
