"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

ALL that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the southeasterly side of East Woodburn Drive, near the City of Greenville, S. C., being known and designated as Lot No. 71 on plat entitled "Final Plat Seven Oaks" as recorded in the RMC office for Greenville County, St.C., in Plat Book 4R, page 6 and having, according to said plat, the following motes and bounds, to-wit:
