installments of principal, the first installment of principal being

interest from date of said note payable as and at the rate(s) provided in said note, all of which and such other terms, conditions, and agreements as contained in said note will more fully appear by reference thereto, which note is made a part of this mortgage to the same extent as if it were set out in extenso herein, which said note is secured by this mortgage.

This mortgage also secures (1) all existing indebtedness of first party (or of any one or more of the parties designated heroin as first party) to second party (including but not limited to the above described note) evidenced by promissory notes or any other instruments, and all renewals, reamortizations, extensions, deferments or other rearrangements thereof, together with interest thereon as provided therein, (2) all litture advances that subsequently may be made to first party (or to any one or more of the parties designated herein as first party with the written consent of the remainder of said parties) to be evidenced by promissory notes or any other instruments, and all renewals, reamortizations, extensions, deferments or other rearrangements thereof, together with interest thereon as provided therein, said future advances, if any, to be made solely at the option of second party, and (3) all other indebtedness of first party (or of any one or more of the parties designated herein as first party) to second party now due or to become due or hereafter contracted, and all renewals, reamortizations, extensions, deferments or other reattangements thereof, together with interest thereon as provided for, THE MAXIMUM PRINCIPAL AMOUNT OF ALL EXISTING INDESTEDNESS, FUTURE ADVANCES, AND ALL OTHER INDESTEDNESS OUTSTANDING AT ANY ONE TIME NOT TO EXCEED

DOLLARS (\$ 95,000,00 Ninety Five Thousand plus interest thereon, attorney's fees, court costs, and any advances necessary for the protection of the security or title thereto, such as, but not limited to, advances for taxes and insurance premiums, all of which are secured by this mortgage. It is understood and agreed by all parties hereto that the execution by first party and the acceptance by second party of any notes, renewal notes or other instruments, or the agreement by second party to any reamortizations, extensions, deforments or other rearrangements as contemplated in this paragraph or elsewhere herein shall not be construed as payment of any indebtedness hereby secured (whether or not, among other changes in terms, the interest rate or rates remain the same and/or time or payment is thereby extended or lessened), and shall not discharge the lien of this mortgage which is to remain in full force and effect until the total indebtedness secured hereby has been paid in full. All notes or other instruments contemplated in this paragraph or elsewhere herein shall remain uncancelled and in possession of second party, its successors and assigns, until the total indebtedness hereby secured is paid in full.

NOW, KNOW ALL MEN, that first party, in consideration of the debt as evidenced by the above described note, and for better securing the payment thereof to second party, according to the terms of said note, and the performance of the conditions and covenants herein contained, and to secure any other indebtedness contemplated in the paragraph next above or elsewhere herein, and also in consideration of the sum of One Dollar to first party in hand paid by second party, receipt whereof is hereby acknowledged, has granted, bargained, sold and released, in fee simple, and by those presents does grant, bargain, sell and release, in fee simple, unto second party, its successors and assigns, the following described lands, including but not limited to, all trees, fimber, shrubbery, fixtures and improvements now and hereafter thereon.

All those certain tracts of land, situate, lying and being in the State of South Carolina, County of Greenville, Glassy Mountain Township, School District 436, approximately 2 miles Northwest of the Town of Sowensville, on both sides of Ballew's Mill Creek and S.C. Highway No. 18, bounded now or formerly as follows: North by Greenville Water Shed; Northeast by Paul W. Peoples; East by L.L. Hyder; South by U.S. Plywood-Champion Papers, Inc.; and West by Thomas F. Farmer, et al. Said tracts of land, together containing 110 acros, more or less, and being known and designated as Tracts Nos. 6,7,8,0,10 and 11 on a plat of property prepared for the Estate of Dennis M. Lockhart by J.H. Atkins, Surveyor, dated March, 1934, recorded in Plat Book H, page 239, R.M.C. Office for Greenville County; which plat is, by reference, incorporated herein as part of this description. Said property being identically the same conveyed to Paul W. Peeples by deed of Joe and Leila J. Hyder, recorded in Volume 712, page 213.
