(hereinafter referred to as Mortgagor) SEND(S) GREETING:

(\$ 17,550.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 20 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Hallcox Street being shown and designated as part of lots 81, 82, 83, 84, 85, and 86 on plat of property of Cuttino Heirs, recorded in the RMC Office of Greenville County in Plat Book J at Page 121, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Hallcox Street (said pin being 148.2 feet from the intersection of Cuttino Circle and Hallcox Streets) and running thence S 86-55 W 121.5 feet to an iron pin; thence N 119 feet to an iron pin; thence S 89-40 E 121.6 feet to an iron pin on Hallcox Street; thence along Hallcox Street S 112 feet to an iron pin, the point of beginning.

The above-described property is the same conveyed to the Mortgagors by deed recorded in Deed Book 963at Page 460.
