NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Crabapple Drive (now known as Cunningham Circle), being shown and designated as Lot No. 25 on a plat of CUNNINGHAM ACRES, Section No. 3, made by C. O. Riddle, Surveyor, dated April 8, 1971, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book 4-N, at page 73, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Crabapple Drive (Cunningham Circle) at the joint front corners of Lots Nos. 24 and 25 and running thence along the common line of said lots S. 3-10 E. 165.08 feet to an iron pin on the line of Lot 13; thence along the line of said lot S. 86-50 W. 64.1 feet to an iron pin at the joint rear corners of Lots 25 and 26; thence along the common line of said lots N. 23-02 W. 149.2 feet to an iron pin on Crabapple Drive; thence along the southern side of said Drive N. 69-11 E. 59 feet to an iron pin; thence continuing along the southern side of said Drive N. 80-11 E. 59 feet to an iron pin, the beginning corner.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fix tures and equipment, other than the usual household furniture, be considered a part of the real estate.
