WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, have the right to institute any proceedings upon said note and any collator the storagages, or any supurations set out in this mortgage, the whole amount one increander shall at the option of the noncer thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Austin Township, within the corporate limits of the Town of Mauldin, and being known and designated as Lot No. 5 of a subdivision known as Glendale II, a plat of which is of record in the R.M.C. Office for Greenville County in Plat Book OOO at page 55, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the western side of Hickory Lane at the joint front corner of Lots 4 and 5 and running thence with the western side of Hickory Lane N. 14-30 E. 80 feet to a point at the joint front corner of Lots 5 and 6; thence S. 66-0 W. approximately 258.7 feet to a point in a branch at the joint rear corner of Lots 5 and 6; thence with said branch as the line, approximately S. 54-22 W. approximately 52 feet to a point in said branch; thence continuing with said branch as a line approximately S. 2-53 E. approximately 137 feet to a point in said branch at the joint rear corner of Lots 2 and 5; thence S. 86-28 E. approximately 252.1 feet to a point on the western side of Hickory Lane at the point of beginning.
