"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, lying and being on the Southern side of Garrison Road and containing 2 acres and being shown on a plat entitled "Property of William R. Godfrey, made by Webb Surveying and Mapping Co., May, 1972, said plat being recorded in the R. M. C. Office for Greenville County in Plat Book 4-Q, Page 123, and having, according to said plat, the following metes and bounds, to-wit:

BEGINAIN at a point in the center of Garrison Road at a point 600 feet West of the intersection of said Garrison Road and Snow Road and running thence with Garrison Road S. 50-58 W. 290 feet to a point in the center of said Garrison Road; thence running S. 39-02 E. 300 feet to an iron pin; thence running N. 50-58 E. 290 feet to an iron pin; thence running N. 39-02 W. 300 feet to a point in the center of said Garrison Road, the point of beginning.
