All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 9 Golden Grove Estates, Section 1, as shown on plat thereof recorded in the R.M.C. Office for Greenville County, S.C., in Plat Book 4-R, at page 1, and being described, according to said plat, as follows:
