"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being located in Fairview Township, approximately 3 miles West of the Town of Fountain Inn, and having the following metes and bounds, to wit:

BEGINNING at an iron pin in the center of Wilson Bridge Road at the joint corner of property, now or formerly, of Louis and Helen Thomason, being 704 feet from the intersection of Wilson Bridge Road and Reeley Ferry Road and running thence in a Northeasterly direction along Thomason line 264 feet to an iron pin; thence turning and running in an Easterly direction 334 feet to an iron pin; thence in a Southwesterly direction 400 feet to an iron pin in the center of Wilson Bridge Road; thence with the center line of Wilson Bridge Road in a Westerly direction 267 feet to the beginning corner.
