NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, self and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Grove Township, containing one-half (½) of one acre, more or less, adjoining lands of Prelo Hood, Jr., Prelo Hood, Sr. and the Old Georgia Road, and possibly others, having the following courses and distances to-wit:

BEGINNING at a point in center of Old Georgia Road, at corner of Prelo Hood, Jr., and running thence along line of Prelo Hood, Jr. N. 2-45 W. to an iron pin 214 feet; thence N. 89 W. 100 feet to an iron pin; thence S. 2-45 E. 217 feet to a point in center of Old Georgia Road, new corner; thence along center of Old Georgia Road, N. 89-50 E. 100 feet to the point of beginning.
