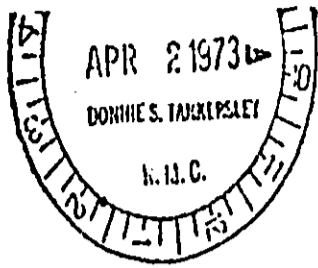

NOW, KNOW ALL MEN, that we the said George W. and Judy Hunter (Mrs. George W.) in consideration of the said debt, and for the better securing the payment thereof, according to the conditions of the said Note; which with all its provisions is hereby made a part hereof; and also in consideration of Three Dollars to the said mortgagor in hand well and truly paid, by the said mortgagee, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Consolidated Credit Corporation of Greenville, South Carolina, Its Successors

All that lot of land with the buildings and improvements thereon situate on the north side of Anglewood Drive and the west side of Sherondale Lane, near the township of Simpsonville, Austin Township, Greenville County, South Carolina being shown as Lot #139 on plat of Section II, Sheet No. II of Westwood Subdivision recorded in the R N C office of Greenville South Carolina in Plat Book 4-F, Page #45, and having, according to said plat, the following metes and bounds to wit:

Beginning at an iron pin on the west side of Sherondale Lane at the joint corner of Lots #138 and #139 and runs thence along the line of Lot 140-S, 25-39 E. 173.71 feet to an iron pin on the north side of Anglewood Drive (The chord being N. 44-12 E. 52 feet) to an iron pin, thence continuing with the curve of Anglewood Drive (The chord being N. 54-02 E. 48 feet) to an iron pin at the intersection of Anglewood Drive and Sherondale Lane, thence with the intersection of said drive and line N. 13-09 E. 37-8 feet to an iron pin on the west side of Sherondale Lane, thence with the curve of Sherondale Lane (the chord being N. 27-44 W. 51.5 feet to an iron pin, thence continuing with the curve of Sherondale Lane, (The chord being N. 18-48 W. 46.8 feet to the beginning corner...)
