BEGINNING at an iron pin on the northerly side of State Park Road at the joint front corner of Lots 3 and 4; and running thence with the line of said lots N 33-30 W 190.2 feet to a point on an alley; thence with said alley, S 68 W 66 feet to a point on Grand View Circle; thence with Grand View Circle S 3-15 E 100 feet to point; thence still with Grand View Circle S 15-15 E 91 feet to curve at the intersection of Grand View Circle and State Park Road; thence with said curve, 25 feet to a point on State Park Road; thence with State Park Road N 56-30 E 130 feet to the point of beginning, being the same conveyed to us in Deed Book 804, at page 72.
