"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of East White Horse Road Extension, Greenville County, State of South Carolina being apart of Lot Number 2, Unit 3 as shown on plat of Pine Crest Farms, dated April 1940, recorded in Plat Book M at Page 3 of the RMC Office for Greenville County and plat made by Pickell and Pickell August 14th, 1947 and having the following metes and bounds, to-wit:
