NOW, KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, with improvements thereon, situated in the Town of Fountain Inn, and being known and designated as Lot No. 26 and part of Lot No. 25 in Belmont Estates, according to plat made by Carolina Engineering and Surveying Company, recorded in the RMC Office for Greenville County in Plat Book PPP at page 87, and being more fully described in accordance with said plat, towit:

BEGINNING at an iron pin on the northern side of Belmont Drive, being the western corner of Lot No. 26, and running thence N. 27-20 E., 242.2 feet to an iron pin; thence S. 60-28 E., 150 feet to a point in the middle of Lot No. 25; thence S. 27-20 W., 264.4 feet, more or less, to point on Belmont Drive; thence N. 52-0 W., 151.7 feet to an iron pin, being the point of beginning.
