AIL that certain piece, parcel or lot of land situate, lying and being ir the Town of Mauldin, being known as property of Lewis J. McKinney as shown by plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book III at page 49, and to a more recent plat entitled "Property of James A. Mulkey and Barbara L. Mulkey", dated April 25, 1973, prepared by Carolina Engineering and Surveying Company.

According to said plat, this lot fronts 69.6 feet on the southeastern side of Sunrise Drive with a depth of 282.8 feet on one side, a depth of 38.13 feet and 247.3 feet on the other side and being 50 feet across the rear.
