C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of FOURTEEN THOUSAND ONE HUNDRED THIRTY-FIVE -----

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as Lot No. 11, Williams Street, as shown on a plat of Whipporwill Hills, Section 1, prepared by R. B. Bruce, RLS, which plat is of record in the Office of the RMC for Greenville County in Plat Book 4N at page 20, and having the following courses and distances, to wit:
