All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, bying and being in the State of South Carolina, County of Greenville, designated as Lot 22 of Pelham Estates, Section II, according to a plat dated May 12, 1967 prepared by Piedmont Engineers and Architects and recorded in the R.M.C.
