That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in confideration of the sum of Three Dollars is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chicks Springs Township, cn the Southwestern corner of the intersection of U. S. Highway No. 29 and Black Hawk Circle, being shown and designated as Lot No. 1 of Black Hawk Circle shown on a plat recorded in the RMC Office for Greenville County, South Carolina in Plat Book PP, page 193 and having according to said plat the following metes and bounds to-wit:

BEGINNING at an iron pin on the Southwestern corner of the intersection of Black Hawk Circle with the right of way of U. S.
