BEGINNING at an iron pin on the southern side of Burgess Drive at joint front corner of Lots 24 and 25 and running thence along line of Lot #25 S. 2-41 W. 184.9 feet to an iron pin; thence N. 74-50 W. 132 feet to an iron pin on the eastern side of Enoree Circle along Enoree Circle N. 7-07 W. 64.8 feet and N. 2-41 E. 68 feet to an iron pin at corner of intersection of Enoree Circle and Burgess Drive around corner of said intersection and following the curvature thereof, the chord being N. 47-45 E. 35.3 feet to Iron pin on southern side of Burgess Drive along Burgess Drive S. 87-19 E. 116 feet to beginning corner.
