It is hereby agreed, that should any default be made in the payment of interest on said first mortgage, and such interest remains unpaid and in arreats for ten days, or should any suit be commenced to foreclose said first mortgage, then the amount secured by this mortgage and the accompanying note shall become and be due and payable at any time thereafter at the option of the owner or holder of this mortgage.
