"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina. County of Greenville,

All that lot of land in the County of Greenville, State of South Carolaina, in Fairview Township, just outside the Town of Fountain Inn., containing .49 acre, more or less, as shown on a plat by E. E. Gary, dated March 28, 1947, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern side of Fairview Street, joint corner of property now or formerly of E. R. Bradley; thence along the Bradley line S.32 E. 217.4 feet to an iron pin; thence N. 55 E. 99 feet to an iron pin; thence N. 32 W 217.4 feet to an iron pin on the Southern side of Fairview Street; thence with the side of said Street S. 55 W. 99 feet to the point of beginning.

The Mortgagor further covenants to warrant and forever defend all and singular the said premises , unto the Mortgagor forever, from and against the Mortgagor and all persons whomsoever landfully claiming the same or any part thereof.
