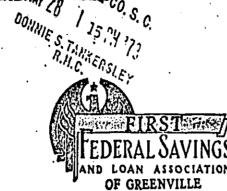

That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southerly side of Ramblewood Lane, being known and designated as Lot No. 7 on plat of "Addition to Wildaire Estates" prepared by Piedmont Engineering Service November, 1962 and recorded in the R. M. C. Office for Greenville County in Plat Book RR, at Page 100, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Ramblewood Lane, joint front corner of Lots Nos. 6 and 7, and running thence with the line of Lot No. 6, S. 16-44 E. 175 feet to an iron pin in the line of Lot No. 3; thence with the line of Lots Nos. 3 and 4, N. 75-52 E. 100.1 feet to an iron pin, joint rear corner of Lots Nos. 7 and 8; thence with the line of Lot No. 8, N. 16-44 W. 180 feet to an iron pin on the southerly side of Ramblewood Lane; thence with the southerly side of Ramblewood Lane, S. 73-16 W. 100 feet to the beginning corner; being the same conveyed to us by Don L. Red and Ona B. Reid by deed of even date, to be recorded herewith.
