MORTGAGE

STATE OF SOUTH CAROLINA COUNTY OF GREENVILLE

TO ALL WHOM THESE PRESENTS MAY CONCERN: Jimmie E. Fulp and Barbara K. Fulp

(hereinafter referred to as Mortgagor) SEND(S) GREZTING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagoe) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Thirty-One Thousand Two Hundred Fifty and No/100------

DOLLARS (\$ 31,250.00), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable, May, 2003.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the eastern corner of the intersection of Broadford Road and Sutherland Hill Road and being known and designated as Lot NO. 160 on a plat of DEL NORTE ESTATES Subdivision, plat of which is recorded in the RMC Office for Greenville County in Plat Book "WWW" at Pages 32 and 33 and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southern side of Broadford Road at the joint front corner of Lots 159 and 160 and running thence S.48-32 E. 145 feet to an iron pin at the joint rear corner of said Lots; thence S.36-48 W. 111.3 feet to an iron pin on the eastern side of Sutherland Hill Road; thence with said Road N.48-40 W. 120 feet to an iron pin; thence N.5-55 W. 36.73 feet to an iron pin on the southern side of Broadford Road; thence with said Road N.36-45 E. 86.7 feet to the point of beginning.
