), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said (\$ 85,000.00 note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgageo, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated on a plat entitled "Survey for B. T. M. Corporation" made by Piedmont Engineers - Architects - Planners, May 30, 1973, and recorded in the R.M.C. Office for Greenville County in Plat Book 5A at Page \_\_36\_. According to said plat the property is more fully described as follows:

BEGINNING at an iron pin on Old Anderson Road (S. C. #81)/west of the intersection of East Welcome Road and running thence along Old Anderson Road S 38-54 W 98.35 feet to an iron pin at the corner of other property owned by Mortgagor; thence along the joint line of ther property owned by Mortgagor, N 26-50 W 173.5 feet to a n iron pin; thence continuing N 32-43 W 131.9 feet to an iron pin; thence N 61-43 E 90.85 feet to an inon pin; thence S 32-43 E 124.65 feet to an iron pin, thence continuing S 26-50 E 142.25 feet to an iron pin, the point of Beginning.
