, hereinafter called the Mortgagor, is indebted to Greenville, South Carolina Thomas & Hill, Inc., a West Virginia Corporation, with principal place of business at 950 Kanawha Boulevard, Charleston, West , a corporation Virginia 25327 organized and existing under the laws of West Virginia , hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Fifteen Thousand Nine Hundred and No/100----- Dollars (\$ 15,900.00), with interest from date at the rate of Seven----- per centum (--- 7 %) per annum until paid, said principal and interest being payable at the office of Thomas & Hill, Inc., 950 Kanawha Boulevard , or at such other place as the holder of the note may Charleston, West Virginia designate in writing delivered or mailed to the Mortgagor, in monthly installments of One Hundred Five and 89/100 ----- Dollars (\$ 105.89----), commencing on the first day of July , 1973, and continuing on the first day of each month thereafter until the painties of the painti interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of May ,2003 •

Now, Know All Men, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of Greenville

, State of South Carolina;

ALL that piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being on the north side of Pleasant Ridge Avenue in the City of Greenville, County of Greenville, State of South Carolina, being shown as Lot 22 on Plat of Pleasant Valley, made by Dalton & Neves Engrs. April 1946, recorded in the RMC Office for Greenville, S. C. in Plat Book P, Page 93, said lot fronting 60 feet on the north side of Pleasant Ridge Avenue, with a deoth of 160 feet on the east side to a depth of 160 feet on the west side and being 60 feet across the rear.
