"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, SC

Beginning at an iron pin on the South Side of the South Access Road of

Interstate Highway 85 as shown on the plat, being a joint front corner with the Brazzell Property and running thence S. 23-53 E. 74.1 Feet along a traverse line, the branch is the line to an iron pin; thence S.27-58 W. 87 feet along the joint line with Brazzell property to an iron pin, thence N 81-47E. 101.8 feet along the line of other property of the grantor to an iron pin; thence N. 11-09 E 150 feet along Duke Power Co. Righe a way to an iron pin on the South side of said Access Road; thence along the Access Road 3; 81-47 W. 120 feet to the point of beginning.
