ALL that piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being in the Town of Mauldin, in the County of Greenville, State of South Carolina, being known and designated as Lot 46, on Plat of Parkwood Subdivision, Section I, which plat is recorded in the Disc Office for Greenville County, South Carolina, in Plat Book in the RMC Office for Greenville County, South Carolina, in Plat Book 4-F, Page 22.

The following items are hereby acknowledged as part of the mortgaged property: Range or Counter Top Unit, Hood Fan, Carpet, and Patio.
