All of those certain lots of land lying in the State of South Carolina, County of Greenville, City of Greenville, on the southwestern side of Buncombe Street, actually running between the southwestern side of Buncombe Street and the northeastern side of Norwood Avenue, also known as 1101 Buncombe Streets, and being designated as Lots 2 and 12 on a plat of the G. A. Norwood property recorded in the R.M.C. Office for Greenville County in Plat Book A at Page 265 and being funther described as follows:
