That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southerly side of Providence Square, being shown and designated as Lot No. 31, on plat of Section Two, Pelham Estates, recorded in the RMC Office for Greenville County, S. C., in Plat Book "PPP", at Page 119, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Providence Square, joint front corner of Lots Nos. 31 and 32, and running thence with the joint lines of said Lots, S. 13-12 W. 210.3 feet to an iron pin; thence S. 76-49 E. 150 feet to an iron pin, joint rear corner of Lots Nos. 30 and 31; thence with the joint lines of said Lots, N. 13-12 E. 210.2 feet to an iron pin on the southerly side of Providence Square; thence with the southerly side of Providence Square, N. 76-48 W. 150 feet to the point of BEGINNING.
