That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Misty Creek Lane, being known and designated as Lot No. 17 on plat of Supreme Forest, prepared by Piedmont Engineers and Architects dated October 26, 1972, recorded in the RMC Office for Greenville County in Plat Book 4X at Page 6, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNNING at an iron pin on the southern side of Misty Creek Lane at the joint front corner of Lots 17 and 18 and running thence with Lot 18, S 17-56 W 167.85 feet to an iron pin at the joint rear corner of Lots 17 and 18; thence S 72-04 E 150 feet to an iron pin at the joint rear corner of Lots 16 and 17; thence with Lot 16, N 18-02 E 170.2 feet to an iron pin on Misty Creek Lane; thence with said Lane, N 72-55 W 150 feet to the point of beginning.
