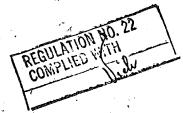

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagor factoring account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

Mortgagor's account for the payment of the Mortgagor, in consideration of said debt and to sec re the payment thereof and any further thurs which may be advanced by the Mortgagor in hortgagor's account, and also in consideration of the sum of Three Dollars (12.00) by the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

Greenville, on the northwestern side of Lionel Greenville, on the northwestern side of Lionel Gourt, being known and designated as Lot No. 45 as shown on plat entitled CAMELOT, dated November 5, 1968, prepared by Piedmont Engineers and Architects, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book "WWW" at Page 46, and having, according to said Rlat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Lionel Court at the joint front corner of Lots Nos. 44 and 45 and running thence with the common line of said Lots, N. 62-11 W. 162.16 feet to an iron pin; thence running N. 40-03 E. 210.0 feet to an iron pin; thence running S. 53-28 E. 80.8 feet to an iron pin at the joint corner of Lots Nos. 46 and 47 in the line of Lot No. 45; thence running with the common line of Lots Nos. 45 and 46, S. 1-28 W. 149.8 feet to an iron pin on the northwestern side of Lionel Court; thence running with the northwestern side of Lionel Court, the following courses and distances: S. 74-49 W. 35 feet to an iron pin; thence running S. 32-51 W. 35.0 feet to the point of beginning.
