The Mortgager further coverants and agrees as follows:

- (B) That this mortgage shall secure the Mortgages for such for ther sums as may be edvanced hereafter, as the option of the Mortgages, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the coverants herein this mortgages shall also secure the Mortgages for any further loans, advances or credits that may be made hereafter, to the Mortgager by the Mortgages so long as the total indebtedness thus secured does not exceed the original amount shown on the fact hereaf. - (5) That it will keep all improvements now existing or hereafter erected in good repair, and, in the case of a construction less that it will continue construction until completion without interruption, and should it tail to do so, the Mortgages may, as its epition enter upon said premises, make whatever repairs are necessary, including the completion of any construction werk underway, and charge the expenses for such repairs or the completion of such construction to the mortgage debt.
- (4) That it will pay, when due, all taxes, public assessments and other governmental or municipal charges, fines or other impossitions against the mortgaged premises. That it will comply with all governmental and municipal laws and regulations affecting the mortgaged premises.

Should any legal proceedings be instituted for the foreclosure of this mortgage, or should the Mortgagee become a party of any suitifinvolving this Mortgage or the title to the premises described herein, or should the debt secured hereby or any part thereof be placed in the hands of any attorney at law for collection, by suit or otherwise, all costs and expenses incurred by the Mortgagee, and a reasonable attorney's fee, shall thereupon be ome due and payable immediately or on demand, at the option of the Mortgagee, as a part of the debt secured hereby, and may be recovered and collected hereunder.
- (7) That the Mortgagor shall hold and enjoy the premises above conveyed until there is a default under this mortgago or in the note secured hereby. It is the true meaning of this instrument that if the Mortgagor shall jully perform all the terms, conditions, and cores nants of the mortgage, and of the note secured hereby, that then this mortgage shall be utterly null and void; otherwise to remain in full force and virtue.
