All that piece, parcel or lot of land situate, lying and being in Austin Township, the County of Greenville, State of South Carolina, on the southwestern side of the cul-de-sac of Mornington Court, being shown and designated as Lot No. 82 on a Plat of HOLLY TREE PLANTATION, made by Enwright Associates, Inc., Engineers, dated May 28, 1973, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book 4-X at Page 32 through 37, inclusive, and having, according to said plat, the following metes and bounds,

BEGINNING at an iron pin on the southwestern side of Mornington Court at the joint front' corner of Lots Nos. 82 and 83 and running thence with the common line of said Lots, S. 33-47 E. 56.0 feet to an iron pin at the joint corner of Lots Nos. 83 and 84 in the line of Lots Nos. 82; thence running with the common line of Lots Nos. 82 and 84, S. 37-02-18 W. 198.0 feet to an iron pin; thence running N. 27-41-02 W. 130.85 feet to an iron pin at the joint rear corner of Lots Nos. 81 and 82; thence running with the common line of said Lots, N. 42-52 E. 128.0 feet to an iron pin on the southwestern side of Mornington Court; thence running with the curve of the southwestern side of Mornington Court, the chord of which is S. 65-19-02 E. 57.0 feet to the point of beginning.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgages forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor further covenants and agrees as follows:

- (f) That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein. This mortgage shall also secure the Mortgagee for any further loans, advances, readvances, readvances or credits that may be made hereafter to the Mortgager by the Mortgagee so long as the total indebtedness thus secured does not exceed the offsinal amount shown on the face hereof. All sums so advanced shall bear interest at the same rate as the mortgage debt and shall be payable on demand of the Mortgagee unless otherwise provided in writing.
- (2) That it will keep the improvements now existing or hereafter erected on the mortgaged property insured as may be required from time to time by the Mortgagee against loss by fire and any other hazards specified by Mortgagee, in an amount not less than the mortgage debt, or in such amounts as may be required by the Mortgagee, and in companies acceptable to it, and that all such policies and renewals thereof shall be held by the Mortgagee, and have attached thereto loss payable clauses in favor of, and in form acceptable to the Mortgagee, and that it will pay all premums therefor when due; and that it does hereby assign to the Mortgagee the proceeds of any policy insuring the mortgaged premises and does bereby authorize each insurance company concerned to make payment for a loss directly to the Mortgagee, to the extent of the balance owing on the Mortgage debt, whether due or not.
