MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern.

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and impaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgage, or any stipulations set out in this mortgage, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and payable, and suid holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and



NOW, KNOW ALL MFN. That the Mortgagor, in consideration of said debt and to seeme the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and tridy usid by the Mortgagor at and before the scaling of these presents, the receipt whereof is hereby acknowledged, his granted, bargained, sold, and released, and by these presents does grant, pargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of

ALL that piece, parcel or lot of land situate, lying and being on the northwestern side of Dove Tree Road near the City of Greenville, in the County of Greenville, State of South Carolina and known and designated as Lot No. 66 of a subdivision known as Dove Tree, plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book 4X at Page 21 and according to said plat has the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Dove Tree Road at the joint front corner of Lots Nos. 65 and 66 and running thence with the joint line of said lots N. 58-05 W., 158.46 feet to an iron pin; running thence S. 24-47 W., 40 feet to an iron pin; running thence S. 21-29 W., 116 feet to an iron pin at the joint rear corner of Lots Nos. 66 and 67; running thence with the joint line of said lots S. 65-52 E., 140.4 feet to an iron pin on the northwestern side of Dove Tree Road; running thence with the northwestern side of said road N. 25-57 E., 43 feet to an iron pin; thence continuing with said road N. 30-35 E., 92 feet to an iron pin, point of beginning.
