All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Weehawken Circle, being shown and designated as Lot 16 on a revised map of Weehawken Hill dated November 10, 1970 prepared by C. O. Riddle, Surveyor, recorded in the PPC Office of the Greenville County Courthouse in Plat Book 4F at Page 50 and being described, according to said plat, more particularly, to-wit:
