WHEREAS, the Mortgagor is well and truly indebted unto Colonial Mortgage Service Company

, a corporation organized and existing under the laws of Pennsylvania called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Eleven Thousand Four Hundred and No/100----------Dollars (\$ 11,400.00), with interest from date at the rate 7 %) per annum until paid, said principal of Seven----- per centum (and interest being payable at the office of Colonial Hortgage Service Company, 7320 Old York Road or at such other place as the holder of the note may designate in writing, in contally installments of Seventy-Five and 92/100------Dollars (\$ 75.92 consencing on the first day of September , 19 73, and on the first day of each south thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of August

NOT KNOT ALL MEN. That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville State of South Carolina:

All that piece, parcel or lot of land, situate, lying and being in the City of Greenville, State of South Carolina and County of Greenville, on the southern side of Harvley Street and being known and designated as Lot No. 18 on plat of property of W. M. Jordan and F. H. & J. G. Cunningham recorded in the RMC Office for Greenville County in Plat Book "E" at Page 214, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southern side of Harvley Street at the joint front corner of Lots Kos. 17 and 18 and running thence along the joint line of said Lots S.O1-56 W. 139.1 feet to an iron pin; thence N.87-43 K. 50 feet to an iron pin; thence along the joint line of Lots Nos. 18 and 19 H.O1-56 E. 138.8 feet to an iron pin; thence along the south side of Harvley Street S.88-04 E. 50 feet to the point of beginning.

"The grantors covenant and agree that so long as this Deed of Trust, Security Deed, or Mortgage whichever is applicable, and the Note secured hereby are guaranteed under the Servicemen's Readjustment Act, or insured under the provisions of the National Housing Act, whichever is applicable, he will not execute or file for record any instrument which imposes a restriction upon the sale or occupancy of the subject property on the basis of race, color or creed. Upon violation of this covenant, the note holder may, at its option, declare the unpaid balance of the debt secured hereby immediately due and payable."

Together with all and singular the rights, members, hereditaments, and apportenances to the same belonging or in any way incident or apportaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or bereafter attacked to or used in connection with the real estate herein described.

TO HAVE AND TO HOLD, all and singular the said premises unto the Kortgagee, its successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encember the same, and that the premises are free and clear of all liens and encumbrances whatsoever. The Mostgages further covenants to warrant and forever defend all and singular the premises unto the Montpaper forever, from and against the Montgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor covenants and agrees as follows:

1. That he will promptly pay the principal of and interest on the indebtedness evidenced by the said note, at the times and in the manner therein provided. Privilege is reserved to pay the debt in whole, or in an assemble equal to one or more monthly physicals on the principal that are next doe on the note, on the first day of any month prior to ratinity; provided, however, that written rotice of an intention to exercise such privilege is given at least thirty (39) days prior to prepayment; and, provided, further, that in the event the delt is paid in full prior to maturity and
