- context clearly indicates a contrary intent or unless otherwise specifically provided herein, the word "Mortgagor" shall mean "Mortgagor and/or any subsequent owner or owners of the premises," the word "Mortgagee" shall mean "Mortgagee or any subsequent holder or holders of this mortgage," the word "note" shall mean "note secured by this mortgage," the word "person" shall mean "an individual, corporation, partnership or unincorporated associate," and the word "premises" shall include the real estate hereinbefore described, together with all equipment, condemnation awards and any other rights or property interest at any time made subject to the lien of this mortgage by the terms hereof, and pronouns of any gender shall include the other.
