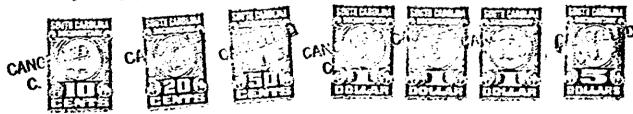

All that piece, parcel or lot of land, situate, lying and being in Fork Township, School District Number 4, Anderson County, South Carolina, and being designated as Lot Number Six (6) on a Plat made by Harold Hawkins, R. S., dated July 28, 1962, recorded in the Office of the Clerk of Court for Anderson County, in Plat Book 47, at Page 261. The lot herein lies on the northwest side of an unnamed street and fronts on the west side of said street for a distance of 100 feet and runs back in parallel lines for a distance of 150 feet, with its rear line being 100 feet; bounded on the north by Lot No. 5, on the east by said street, on the south by Lot No. 7, and on the west by U. S. Government land.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. This mortgage shall also secure the Mortgagee for any further bases, advances, readvances or credits that may be made hereafter to the Mortgagee by the Mortgagee so long as the total indebtedness thus secured does not exceed the original amount shown on the face hereof. All sums so advanced shall bear interest at the same rate as the mortgage debt and shall be payable on demand of the Mortgagee unless otherwise provided in writing.
