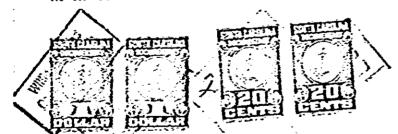

BEGINNING at an iron pin on the northern side of Walker Springs Road at the joint front corner of the Homer C. & Syble Ross property and the front corner of Lot 1, and running thence with the common line of said Ross property and Lot 1 N. 5-15 E. 140.0 feet to an iron pin; thence running S. 85-43 E. 85.15 feet to an iron pin at the joint rear corner of Lots 1 and 2, and running thence with the common line of said Lots S. 4-17 W. 140.0 feet to an iron pin on the northern side of Walker Springs Road; thence with the line of said Road N. 85-43 W. 87.5 feet to the point of beginning.
