"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina County of Greenville, in Greenville Township, being known and designated as Lot No. 67 of section 1, as shown on a subdivision of Victor Monaghan Mills, recorded in Plat Book S at Page 179, and being more particularly described according to said plat as follows:

BEGINNING at the southwestern intersection of Frost Street and Peace Street, and running thence with Frost Street, S. 6-39 W. 100 feet to an iron pin; thence N. 83-21 W. 127.6 feet to an iron pin in the eastern side of a 15 foot alley; thence with said alley, N. 7-28 E. 100 feet to an iron pin in the southern side of Peace Street; thence with said Street, S. 83-21 E. 126.2 feet to the point of beginning.
