ALL that piece, parcel or lot of land with all buildings and improvements thereon, situate, lying and being on the northern side of Sylvania Avenue in the County of Greenville, State of South Carolina being shown and designated as Lot No. 20 on a plat of LEAWOOD made by Dalton & Neves Surveyors, June, 1938 recorded in the RMC Office for Greenville County, South Carolina in Plat Book J, pages 18 and 19 and having according to said plat the following metes and bounds, to-wit:
