

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

(\$ 21,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 25 years after the date hereof, unless extended by mutual coasent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being shown and designated as Lot No. 254, Section 6, Colonial Hills, as shown on a plat prepared by Piedmont Engineers, dated April 2, 1968, and recorded in the Office of the RMC for Greenville County, South Carolina in Plat Book WWW at Page 12, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northerly side of Creighton Street, which iron pin is the joint front corner of Lots 253 and 254 and running thence along the Northerly side of Creighton Street N. 62-00 W. 80 feet to an iron pin; thence N. 26-05 W. 40.5 feet to an iron pin; thence N. 9-45 E. 125 feet to an iron pin; thence S. 63-53 E. 126.2 feet to an iron pin; thence S. 17-57 W. 148.85 feet to and iron pin, the point of Beginning.
