

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, hing and being in the State of South Carolina, County of Greenville, and lying and being on the eastern side of South Warwick Road in Paris Mountain Township, being known as Lot No. 78 of a subdivision known as Stratford Forest, a plat of which is recorded in the RMC Office for Greenville County in Plat Book KK at Page 89 and having, according to said plat, the following metes and bounds, to-wit:
