MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAT CONCERN:









WHEREAS, We, Daniel A. & Janis Reber

(hereinafter referred to as Mortgagor) is well and truly indebted unto C N Mortgages, Inc.

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Inirteen thousand one-hundred seventy-eight and

In eighty-four (84) monthly installment of one-hundred fifty-six and 89/100 dollars (156.89) beginning the eleventh day of January, 1974 and ending December 11, 1980.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of All that piece, parcel or lot of land situate, lying and being in the City and County of Greenville, State of South Carolina, on the Southeastern side of East Faris Road and being known and designated as Lot No. 23 and a ten foot strip off of Lot No. 24 on plat of Kanatenah recorded in the RMC Office for Greenville County in Plat Book "F", at page 131, and having the following metes and bounds, to-wit:

Beginning at an iron pin on the southeastern side of East Faris Road at the joint front corner of Lots 22 and 23 and running thence along the joint line of said lots S. 25-51 E. 156.6 feet, more or less, to an iron pin at the joint rear corner of said lots; thence N. 63-30 E. 70 feet to an iron pin; thence N. 25-51 W. 153.5 feet to an iron pin on the southeastern side of East Faris Road; thence along the Southeastern side of East Faris Road S. 63-20 W. 70 feet to the point of beginning.

The above lot 23 was conveyed to the Grantor by deed recorded in Deed Book 243, at page 88. See Deed Book 331 at page 160 for Lot 24. A portion off of the front of said Lots was conveyed to the City of Greenville for street purposes by deed recorded in Deed Book 440, at page 411.

ALSO, all that piece, parcal or lot of land in the State of South Carolina, County of Greenville, in Greenville Township, being known as designated as Lot No. 6, Block E. of the O.P. MILLS Property as shown on plat recorded in Plat Book C at page 176, and more particularly described according to said plat as follows:

BEGINNING at an iron pin on the northern side of Prentiss Avenue, corner Lot 4, which point is 132 feet from the corner of Elm Street and Prentiss Avenue and running thence along the northern side of Prentiss Avenue, S. 45-27 W.

66 feet to an iron pin, corner of Lot 8; thence with the line of Lot 8, **See Below Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor further covenants and agrees as follows:

(1) That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein. (2) That it will keep the improvements now existing or hereafter erected on the mortgaged property insured as may be required from time to time by the Mortgagee against loss by fire and any other hazards specified by Mortgagee, in an amount not less than the mortgage debt, or in such amounts as may be required by the Mortgagee, and in companies acceptable to it, and that all such policies and renewals thereof shall be held by the Mortgagee, and have attached thereto loss payable clauses in favor of, and in form acceptable to the Mortgagee, and that it will pay all premiums therefor when due; and that it does hereby assign to the Mortgagee the proceeds of any policy insuring the mortgaged premises and does hereby authorize each insurance company concerned to make payment for a loss directly to the Mortgagee, to the extent of the balance owing on the Mortgage debt, whether due or not.

(3) That it will keep all improvements now existing or hereafter erected in good repair, and, in the case of a construction loan, that it will continue construction until completion without interruption, and should it fail to do so, the Mortgagee may, at its option, enter upon said premises, make whatever repairs are necessary, including the completion of any construction work underway, and charge the expenses for such repairs or the completion of such construction to the mortgage debt. **N. 44-33 W. 180 feet to an iron pin on the southern side of a 16 foot alley; thence with the southern side of said alley, N. 45-27E, 66 feet to an iron pin, corner of Lot 4, S. 44-33 E. 180 feet to the beginning corner.
