

SCHEDULE "A"

All that lot of land in Greenville County, State of South Carolina, on the northern side of Woodridge Circle, Near the Town of Simpsonville, being shown as Lot No. 34 on a plat of Windsor Park recorded in Plat Book RR, at page 25, and described as follows:

BEGINNING at an iron pin on the eastern side of Woodridge Circle at the corner of Lot 35, and running thence with the line of said lot N. 29-18 E. 216.4 feet to an iron pin; thence S. 76-30 E 80 feet to an iron pin; thence S. 21-0 E. 130 feet to an iron pin at the corner of Lot 33; thence S. 58-11 W. 194.4 feet to iron pin on Woodridge Circle; thence with the curve of the eastern side of Woodridge Circle, the chord of which is N. 50-52 W. 80 feet to the beginning.  
Being on of the lots conveyed to the Grantor By deed recorded in Deed Book 649, at page 446. This conveyance is made subject to restrictions recorded in Deed Book 647, at page 237.

ALL that lot of land in Greenville County, State of South Carolina, on the northern side of Woodridge Circle, near the town of Simpsonville, being shown as Lot No. 36 on a plat of Windsor Park recorded in Plat Book RR at Page 25 and described as follows:

BEGINNING at an iron pin on the northern side of Woodridge Circle at the corner of Lot No. 35 running thence with the northern side of said circle N. 76-30 W. 100 feet to an iron pin at the corner of Lot No. 37; thence with the line of said Lot N. 13-30 E. 200 feet to an iron pin; thence S. 76-30 E. 100 feet to an iron pin at the corner of Lot No. 35; thence with the line of said lot S. 13-30 W. 200 feet to the beginning corner, and being one of the lots conveyed to the grantor by deed recorded in Deed Book 649 at Page 452.

ALL that lot of land situate on the north side of Woodridge Circle, near the Town of Mauldin, in Greenville County, South Carolina, being shown as Lot No. 35 on plat of Windsor Park made by R. K. Campbell, Surveyor, March 29, 1969, recorded in the RMC Office for Greenville County in S.C. in Plat Book RR, page 25, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the North side of Woodridge Circle, at joint front corner of Lots 34 and 35, and runs thence along the line of Lot 34, N. 29-18 E. 216.4 feet to an iron pin; thence N. 76-30 W. 144.4 feet to an iron pin; thence with the line of Lot 36, S. 13-30 W. 200 feet to an iron pin on the North side of Woodridge Circle; thence along Woodridge Circle, S. 76-30 E. 35.2 feet to an iron pin; thence still with the curve of Woodridge Circle (the chord being S. 68-47 E. 64.8 feet) to the beginning corner.
